

SICA presents < 196 exhibit

Long Branch — SICA, The Shore Institute of the Contemporary Arts, 20 Third Ave., announces its upcoming Juried show, < 196. This show includes 2D art that is less than 196 square inches or 3D which is less than 2,744 cubic inches.

The exhibit runs from Feb. 11-Apr. 8, with an opening reception on Sun., Feb. 13, 3-6 p.m.

The jurors are Elizabeth & Bob McKay, Co-Owners of McKay's Imaging (Red Bank) for photography and Lawrence Cappiello and Rachael Faillace, Director and Assistant Director [respectively] of the Arts Guild New Jersey (Rahway) for all other medias.

This exhibition was open to all visual artists in all mediums, for works that had been completed in the past 5 years and that had never been displayed at SICA. There were over 220 works submitted, from which 72 works, by 56 artists were chosen for this exhibition.
